Joshua 4

FIRST DAY: Introduction

Do you keep a record of the prayers God has answered? Do you write down the wonders God has done in your life? We are so quick to forget all the work that God has done for us. This forgetfulness is detrimental to our faith and our future in possessing all the promises of God. In Psalm 103:2, David exhorted his *soul* to *forget not all His benefits*. It has been said God's past faithfulness in our lives is the fodder for our future faith. It is essential that we remember and not forget all the great things God has done for us!

God knew the children of Israel would need visual reminders of the wonders He did for them when He led them across the Jordan River and into the Promised Land. These visual reminders would not only keep them from forgetting God's marvelous faithfulness toward them, but also embolden their faith to possess the land. The work of God was also to be memorialized in order to establish faith in their children.

Ask God to help you recall His past faithfulness so that your faith will be strengthened!
